- 2. Below are all the questions and answers from the mandatory job walk:
- Q1. For line items that indicate a quantity of zero, do we put in a price or just enter "0"?
  - A1. Original line items 12 through 17 that contained quantity of zero have been deleted. Please note that the new line items associated with the three (3) delivery batches are now as follows:
    - Batch 1 Line 1 through 72 should be delivered on January 3, 2011.
    - Batch 2 Line 73 through 155 should be delivered on July 5, 2011.
    - Batch 3 Line 156 through 230 should be delivered on January 3, 2012.
- Q2. Does my company get five percent (5%) bid price reduction credit each for a total of 10 % reduction if I qualify for both SBE and DVBE?
  - A2. No, if you qualify for both SBE and DVBE your company will **only** receive a total of five percent (5%). However, your company may also received an additional five percent (5%) bid price reduction credit if you qualify as a Regional Business Enterprise (RBE).
- Q3. Will you accept alternate brand components?
  - A3. Yes, you may propose alternate brand ('or equal") components.
- Q4. Must all components have UL approval?
  - A4. All components must meet UL listed.
- Q5. Do you want entire bucket set up/assembled with associated components?
  - A5. No, just provide components and MWD staff will assemble.
